Pursuant to the constitution of the Republican Party of Minnesota and pursuant to the Official 2026 Call for the Republican Party of Minnesota BPOU Conventions issued by the Republican Party of Minnesota State Executive Committee, the Republican Party of Wright County Basic Political Unit is hereby called to meet at:

**Buffalo High School, 877 Bison Blvd, Buffalo, MN** on Saturday, **February 21st at 9:00 AM.**

*The voting body of this convention* shall be composed of delegates and alternates *elected at* the Precinct Caucuses on February 3rd, 2026 *in Senate Districts 29 and 30 and the precincts from SD17 within the borders of Wright County*

Registration opens at 8:00 AM and closes at 9:30 AM. **Pre-Registration will be \$25 for all delegates and alternates.** A \$10.00 fee will be collected from each guest over the age of 18. Add \$1.50 if registering with a credit card.

The convention shall be held for the purpose of:

1. Endorsement of Candidates for House and Senate of districts 29 and 30
2. Approval of changes to the BPOU Constitution
3. Election of Delegates and Alternates to the CD6 and State Conventions
4. Election of any vacant BPOU Board positions
5. Transaction of other business that may properly come before the convention.
